However, in order to be in the Employer's Plan after January 1, 2009 IRS rules require that the vendor be listed in the Written Plan. To be listed in the Written Plan we require the vendor to sign a vendor agreement. All of the vendors listed below have indicated they will sign this agreement. Most vendors with "grandfathered" contracts under Texas rules have not agreed to sign a vendor agreement.
